


WEEKLY UPDATE

Humans

A total of 19 new cases of West Nile virus (WNV) disease were reported to the California Department of Public Health (CDPH) this week from the following 7 counties: Fresno (1), Kern (1), Los Angeles (11), Orange (3), San Bernardino (1), Stanislaus (1), and Sutter (1). As of November 17, a total of 752 human cases of WNV disease have been reported from 31 counties. As of this date in 2013, 356 cases had been reported from 30 counties. Of the 752 case-patients, 511 (68%) had neuroinvasive illness. The median age of the 752 individuals is 59 years (range: 3 months – 94 years); 476 (63%) are male. Dates of symptom onset for individuals where data are available range from May 15 to November 4. A total of 27 WNV-related fatalities have been reported to CDPH from 11 counties: Glenn (1), Kern (1), Los Angeles (7), Orange (7), Placer (1), Sacramento (2), San Diego (1), Shasta (1), Stanislaus (2), Sutter (3), and Tehama (1). In addition, 82 asymptomatic WNV-positive blood donors have been reported this year from 19 counties: Butte (1), Contra Costa (2), Fresno (11), Kern (3), Kings (1), Los Angeles (23), Orange (15), Placer (2), Riverside (1), San Bernardino (6), San Diego (2), San Francisco (1), San Joaquin (2), Santa Clara (3), Shasta (1), Stanislaus (4), Sutter (1), Tulare (2), and Yuba (1).

Number of reported WNV cases, by week of onset—California, 2013-2014*





Dead Birds

A total of 13 WNV positive dead birds were reported this week from the following 3 counties: Orange (1), San Diego (4), and Santa Clara (8). In 2014, 2,430 dead birds have tested positive for WNV from 36 counties. At this time last year, 1,235 WNV positive dead birds had been detected in 38 counties.

Number of reported WNV positive dead birds, by week of collection-California, 2013-2014*



Mosquito Pools

No positive mosquitoes were reported this week. In 2014, 3,338 mosquito pools from 30 counties have tested positive for WNV. At this time last year, 2,527 WNV positive mosquito pools had been reported from 27 counties.

Number of reported WNV positive mosquito pools, by week of collection-California, 2013-2014*





Sentinel Chickens

Three WNV seroconversions were reported this week from 3 flocks in Los Angeles (2) and Riverside (1) counties. In 2014, 440 WNV positive chickens have been reported from 96 flocks located in 23 counties. At this time last year, 483 WNV seroconversions had been reported from 111 flocks in 26 counties.

Test Protocols

Humans:

Specimens are tested by local laboratories with an IgM or IgG immunofluorescent assay (IFA) and/or an IgM enzyme immunoassay (EIA). Specimens with inconclusive results are forwarded to the California Department of Public Health Viral and Rickettsial Disease Laboratory (VRDL) for further testing or confirmation.

Dead Birds

Oral swab samples from corvids are collected onto RNase cards and tested by the UC Davis Center for Vectorborne Diseases (CVEC) for West Nile virus by the singleplex RT-PCR Taqman assay and confirmed with a second primer set.

Sentinel Chickens:

Dried blood spot specimens from sentinel chickens are submitted to the California Department of Public Health Vector-Borne Disease Laboratory and tested for the presence of antibodies to West Nile, western equine encephalomyelitis (WEEV), and St. Louis encephalitis (SLEV) viruses by EIA and IFA. Positive samples are confirmed by western-blot or PRNT.

Mosquito Pools:

Mosquito pools are submitted to CVEC and screened for WEEV, SLEV, and WNV viral RNA using a Taqman multiplex RT-PCR. CVEC will cease confirmation testing on PCR-positive pools of *Cx. tarsalis* and *Cx. quinquefasciatus* but will continue to confirm multiplex PCR-positive results for other mosquito species using singleplex RT-PCR.
