Weekly Update

Humans

West Nile virus

A total of 17 human cases of West Nile virus (WNV) illness were reported this week from 11 counties: Butte (1), Fresno (1), Kern (3), Los Angeles (1), Merced (1), Riverside (3), Sacramento (1), San Bernardino (1), Stanislaus (1), Tulare (3), and Ventura (1). **These are the first WNV cases reported from Sacramento and Ventura counties this year.** In 2019, 128 WNV human cases have been reported from 19 counties. Of the 128 reported cases, 73 (57%) had neuroinvasive disease and 3 (2.3%) fatalities have been reported. The median age of the individuals is 56 years (range: 11–93 years) and 79 (62%) are male. Dates of symptom onset range from May 12 to September 22. In addition to the 128 cases, 17 asymptomatic infections have also been reported from Butte (1), El Dorado (1), Kern (3), Madera (1), Merced (1), Orange (2), San Bernardino (4), San Joaquin (1), Stanislaus (1), Sutter (1), and Tulare (1) counties. At this time last year, 118 human cases had been reported from 26 counties.

St. Louis encephalitis virus

No new cases were reported this week. In 2019, 5 SLEV human cases have been reported from 3 counties: Fresno (2), Kern (1), and Imperial (2). Of the 5 reported cases, 5 (100%) had neuroinvasive disease. The median age of the individuals is 54 years and dates of symptom onset range from July 14 to August 10. No fatalities have been reported.

Dead Birds

A total of 11 WNV positive dead birds were reported this week from 5 counties: Los Angeles (7), Sacramento (1), San Bernardino (1), Santa Clara (1), and Ventura (1). **This is the first WNV positive dead bird from Ventura County this year.** In 2019, a total of 186 WNV positive dead birds have been reported from 19 counties. At this time last year, 478 WNV positive dead birds had been reported from 20 counties.

Mosquito Pools

West Nile virus

A total of 80 WNV positive mosquito pools were reported this week from 13 counties: Fresno (4), Kern (2), Kings (2), Los Angeles (13), Madera (4), Orange (29), Riverside (1), Sacramento (2), San Bernardino (1), San Joaquin (5), Stanislaus (3), Tulare (11), and Yolo (3). In 2019, a total of 3,206 WNV positive mosquito pools have been reported from 24 counties. At this time last year, 1,939 WNV positive mosquito pools had been reported from 29 counties.

St. Louis encephalitis virus

A total of 17 SLEV positive mosquito pools were reported this week from 8 counties: Fresno (2), Kern (2), Kings (1), Los Angeles (1), Madera (1), Riverside (1), Stanislaus (1), and Tulare (8). In 2019, a total of 337 SLEV positive mosquito pools have been reported from 12 counties: Fresno (55), Imperial (5), Kern (56), Kings (4), Los Angeles (2), Madera (4), Merced (2), Orange (1), Riverside (102), San Bernardino (1), Stanislaus (11), and Tulare (94). At this time last year, 375 SLEV positive mosquito pools had been reported from 8 counties.

Sentinel Chickens

West Nile virus

A total of 5 WNV seroconversions were reported this week from 2 counties: Colusa (2) and Sutter (3). In 2019, 119 WNV positive chickens have been reported from 16 counties. At this time last year, 141 WNV positive chickens had been reported from 16 counties.

St. Louis encephalitis virus

No new seroconversions were reported this week. In 2019, 3 SLEV positive chickens have been reported from 1 county (Merced). At this time last year, 1 SLEV positive chicken had been reported from 1 county.

TEST PROTOCOLS

Humans:

Specimens are tested by local laboratories with an IgM or IgG immunofluorescent assay (IFA) and/or an IgM enzyme immunoassay (EIA). Specimens with inconclusive results are forwarded to the California Department of Public Health Viral and Rickettsial Disease Laboratory (VRDL) for further testing with a plaque reduction neutralization test (PRNT).

Dead Birds

Oral swab samples collected from bird carcasses are tested at the UC Davis Arbovirus Research and Training laboratory (DART) or at a local agency for West Nile virus by RT-qPCR.

Sentinel Chickens:

Dried blood spot samples from sentinel chickens are tested at the California Department of Public Health Vector-Borne Disease Laboratory for IgG antibodies to West Nile, St. Louis encephalitis, and western equine encephalomyelitis viruses by an EIA. Positive samples are confirmed by IFA, western-blot, or PRNT.

Mosquito Pools:

Mosquito pools are tested at DART or at a local agency for West Nile, western equine encephalomyelitis, and St. Louis encephalitis viral RNA using a multiplex RT-qPCR. Invasive *Aedes* mosquitoes (*Ae. aegypti* and *Ae. albopictus*) are also tested at DART for chikungunya, dengue, and Zika viral RNA by a separate RT-qPCR.
