Human Cases

A total of 38 new cases of West Nile virus (WNV) were reported this week from the following 11 counties: Los Angeles (13), Orange (4), Placer (2), Riverside (1), Sacramento (5), San Bernardino (7), San Joaquin (1), Solano (1), Stanislaus (1), Tehama (2), and Yuba (1). As of November 1, 2012, a total of 377 human cases of WNV illness have been reported in 30 counties. Of the 377 case-patients, 244 (65%) had neuroinvasive illness. The median age of the 376 individuals for whom data are available is 55 years (range: 1-93 years); 223 (59%) are male. Dates of symptom onset for all patients ranged from May 23 to October 14, 2012. A total of 15 WNV-related fatalities have been reported in Fresno (2), Glenn (1), Kern (2), Los Angeles (4), Merced (1), Placer (1), Sacramento (2), San Bernardino (1), and Sutter (1) counties. A total of 59 WNV-positive blood donors have been reported this year; 18 individuals developed symptoms and were reclassified as cases.

At this time last year, 140 WNV cases had been reported from 21 counties.

National Comments: As of October 30, 2012, 4,891 cases had been reported nationwide from 47 states and the District of Columbia (DC). This is the highest number of cases reported through the last week of October since 2003. Over 70 percent of the cases have been reported from Texas, California, Louisiana, Mississippi, Illinois, South Dakota, Michigan, Oklahoma, Nebraska, and Colorado. Of the 4,891 cases, 2,498 (51%) were classified as neuroinvasive disease, and 223 (5%) patients died.

Horses

No equine cases were reported this week. In 2012, 21 horses from 12 counties have tested positive for WNV; 7 (33%) died or were euthanized as a result of their illness. At this time last year, 14 equine cases of WNV from 7 counties had been reported.

Dead Birds & Squirrels

A total of 11 WNV positive dead birds were reported this week from 3 counties: Los Angeles (9), San Diego (1), and Shasta (1). This is the first WNV positive dead bird reported from San Diego County. In 2012, 1,614 dead birds and 21 squirrels have tested positive for recent WNV infection from 39 and 5 counties, respectively. At this time last year, 678 dead birds from 26 counties and 24 tree squirrels from 6 counties had tested positive for WNV.

Mosquito Pools

A total of 22 WNV positive mosquito pools were reported this week from 7 counties: Fresno (1), Kern (1), Los Angeles (14), Orange (1), Riverside (1), San Joaquin (3), and Tulare (1). In 2012, 2,814 mosquito pools from 28 counties have tested positive for WNV. At this time last year, 2,077 mosquito pools had tested positive for WNV from 26 counties.

Sentinel Chickens

A total of 15 WNV seroconversions were reported this week from 8 flocks Los Angeles County. In 2012, 507 WNV antibody-positive chickens have been detected among 105 flocks in 21 counties. At this time last year, 369 WNV positive chickens had been detected among 69 flocks in 15 counties.

Test Protocols

Humans:

Specimens are tested by local laboratories with an IgM or IgG immunofluorescent assay (IFA) and/or an IgM enzyme immunoassay (EIA). Specimens with inconclusive results are forwarded to the California Department of Public Health Viral and Rickettsial Disease Laboratory (VRDL) for further testing or confirmation.

Horses:

Serum or brain tissue specimens from horses displaying neurological symptoms are submitted to the California Animal Health and Safety Laboratory (CAHFS) and tested by EIA and PRNT.

Dead Birds and Tree Squirrels:

Dead birds and tree squirrels are necropsied at CAHFS laboratory at University of California, Davis. Oral swabs from American Crows and kidney tissue from all other dead birds and squirrels are forwarded to the UC Davis

Center for Vectorborne Diseases (CVEC) for West Nile virus testing using the singleplex RT-PCR Taqman assay and confirmed with a second primer set.

Sentinel Chickens:

Dried blood spot specimens from sentinel chickens are submitted to the California Department of Public Health Vector-Borne Disease Laboratory and tested for the presence of antibodies to West Nile, western equine encephalomyelitis (WEEV), and St. Louis encephalitis (SLEV) viruses by EIA and IFA. Positive samples are confirmed by western-blot or PRNT.

Mosquito Pools:

Mosquito pools are submitted to CVEC and screened for WEEV, SLEV, and WNV viral RNA using a Taqman multiplex RT-PCR. CVEC will cease confirmation testing on PCR-positive pools of *Cx. tarsalis* and *Cx. quinquefasciatus* but will continue to confirm multiplex PCR-positive results for other mosquito species using singleplex RT-PCR.
