

Human West Nile Virus (WNV) Cases in California, 2005 (reported as of 03/30/2006)

SUMMARY: In 2005, 935 human West Nile virus (WNV) infections were identified from the following local health jurisdictions: Alameda (1), Amador (4), Butte (25), Calaveras (2), Colusa (2), Contra Costa (11), El Dorado (1), Fresno (68), Glenn (13), Humboldt (1), Imperial (1), Kern (68), Kings (32), Los Angeles (47), Madera (19), Merced (28), Nevada (4), Orange (17), Placer (35), Plumas (1), Riverside (104), Sacramento (177), San Bernardino (35), San Diego (1), San Francisco (2), San Joaquin (36), San Mateo (1), Santa Barbara (2), Santa Clara (5), Shasta (1), Solano (5), Sonoma (1), Stanislaus (92), Sutter (9), Tehama (4), Tulare (60), Tuolumne (1), Ventura (1), Yolo (12), and Yuba (6). Of the 935 infections, 101 were initially detected in asymptomatic individuals through screening done at blood banks; 42 individuals later developed symptoms. Eight of the 101 presumptively viremic blood donors did not confirm in follow-up testing, and were subsequently removed from the list. In addition to the individuals detected at blood banks, four individuals who had no symptoms for WNV were detected through the local health department. Of the 880 WNV cases with symptoms, 305 were classified as West Nile neuroinvasive disease cases, 534 as West Nile fever, and 41 were of unknown clinical presentation. The median age for all symptomatic cases where data is available was 51 years (range: 2-95 years). 483 (55%) of the cases were male. There were 19 WNV-related fatalities reported in California in 2005, from Amador (1), Butte (1), Fresno (2), Kings (3), Madera (1), Plumas (1), Riverside (5), Sacramento (1), San Bernardino (1), San Joaquin (1), Stanislaus (1), and Tulare (1) counties. The median age of the 19 fatalities was 78 years.
